

**VILLAGE BOARD OF TRUSTEES MEETING
JULY 20, 2010**

THE VILLAGE BOARD OF TRUSTEES OF CHERRY VALLEY, ILLINOIS, WINNEBAGO AND BOONE COUNTIES, CONVENED IN REGULAR SESSION ON THE 20th DAY OF JULY 2010.

PRESIDENT JIM E. CLAEYSSSEN CALLED THE MEETING TO ORDER AT 7:00 P.M. AND LED THE PLEDGE OF ALLEGIANCE. ROLL CALL WAS TAKEN BY VILLAGE ADMINISTRATOR, DAVID NORD

President Jim Claeysen entertained a motion to adopt the agenda by adding a liquor license request from the Cherry Valley Firefighters Association. James Coppennoll moved that the village board adopt agenda as amended. Stephen Appell seconded. Motion carried by voice vote.

CITIZENS VOICE

President Jim Claeysen asked Mr. Bill Hecht to please come forward and address the village board. Mr. Hecht presented his concerns regarding the police officers lay-off, current garbage contract relating to senior citizen's, and also requested an explanation on how residents who are not hooked-up to the village water system are billed for their sewer usage. President Claeysen stated that the village has over 100 residents that are not hooked-up to the village water system and it is Rock River Water Reclamation that calculates the sewer usage per home. President Claeysen informed Mr. Hecht that per village ordinance these residents have contracts with the village for their water connection points (when the water system was first purchased from the Mall) but when a home owner sells their home they have to hook-up to the village water system. Mr. Hecht thanked the mayor for his time.

PRESIDENT'S REPORT

President Jim Claeysen presented the village board with a Proclamation asking all citizens of the Village of Cherry Valley to join the Cherry Valley Police Department to support the 27th "Annual National Night Out". This is an opportunity for communities across the country to promote police-community partnerships, neighborhood safety, and awareness and cooperation. President Claeysen entertained a motion to adopt this proclamation. Sally Hollembeak moved to proclaim August 3, 2010 as "National Night Out" in the Village of Cherry Valley. Gary Maitland seconded.
