Scott Kramer moved that the village board authorize President Jim Claeysen to sign the “Amended Service Agreement” with Clarke Environmental Mosquito Management Inc. by reducing the Larval Control Inspection to (9) and reducing the Community-wide Truck ULV Treatment to (10) and eliminate the Helicopter Treatment for the 2010 EMM payment to \$31,142.20 total savings \$4,421.80. The Village is in its last year of a three year service agreement with Clark EMM. Sally Hollembeak seconded. A roll call vote was taken.
