**SECTION 82-7 (3) (5) (H) "FENCE CONSTRUCTION"**

James Coppernoll presented the committee with, "An Ordinance Amending the Code of Ordinances for the Village of Cherry Valley, Illinois, Section 82-7 (e)(5)(h). Fence Construction." Stephen Appell asked to add "because of different types of fencing and location the fence installation should be factored in to various zoning classifications and uses". Tad Whitchurch moved to amend the ordinance to add the language. James Coppernoll seconded. Motion carried by voice vote.

Tad Whitchurch moved to send to the November 3, 2008 village board for second and final reading "An Ordinance Amending the Code of Ordinances for the Village of Cherry Valley, Illinois, Section 82-7 (e)(5)(h). Fence Construction" adding Attorney Tyler Moore's language as follows: When considering a permit request which seeks approval for installation or construction of a fence, of which the unfinished side or fence posts will be visible, consideration shall be given to the zoning classification and uses of the surrounding property. James Coppernoll seconded. Motion carried by voice vote.
