

**ORDINANCE COMMITTEE MEETING  
OCTOBER 6, 2009**

*Chairman James Coppernoll called the meeting to order at 7:00 P.M.*

*Trustee members present: Sally Hollebeak*

*Absent: Gary Maitland*

*Also, present: Attorney Jim Stevens; Nancy L. Belt; David Schroeder, Stephen Appell, President Jim Claeysen, Scott Kramer, Joe Caveny & Sergeant Neville*

*James Coppernoll moved to adopt the agenda. Sally Hollebeak seconded. Motion carried by voice vote.*

*Sally Hollebeak moved to approve the September 1, 2009 ordinance committee minutes. James seconded. Motion carried by voice vote.*

**SPECIAL EVENTS ORDINANCE**

*James Coppernoll and committee reviewed Section 26-210, "Special Event Permit" drafted by Attorney Jim Stevens. The following recommendations were discussed:*

- 1. Change #4 "The number and type of security must be approved by the Village prior to the issuance of the permit.*
- 2. Add definition in regards to the number of acres*
- 3. Include a hold harmless page*

*Sally Hollebeak moved to send the special events ordinance to a safety committee meeting and forward the ordinance to a village board meeting for passage. James Coppernoll seconded. Motion carried by voice vote.*

**WIND ENERGY ORDINANCE**

*James Coppernoll presented the committee with a sample ordinance and asked the committee to review his informational packet. James Coppernoll proposed the question if the committee would like to set restrictions to the height of the residential structure/supporting tower for the small wind energy conversion system. The committee continued discussion on setting requirements for height regulations in residential areas. It was the consensus of the committee to review Chairman Coppernoll's information and continue discussion at the November ordinance committee meeting.*

**SECTION 2-561 WHEN BID REQUIRE**

*James Coppernoll presented a draft ordinance by Attorney Jim Stevens "When Bid Require". This ordinance amends section 2-561 from \$10,000.00 to \$20,000.00. Sally Hollebeak moved to send this ordinance to the village board for passage, "An Ordinance Amending the Code of Ordinances for the Village of Cherry Valley, Illinois, Section 2-561. When Bid Required". James Coppernoll seconded. Motion carried by voice vote.*

**SECTION 70-62 WINTER PARKING REGULATIONS**

*James Coppernoll and committee reviewed Joe Caveny's recommendations to Section 70-62 Winter Parking. Joe is recommending removing the following:*

- *"declaring it as an emergency when two inches or more of snow has fallen" and change the language to: regulated by the National Weather Services "winter storm warning".*

- **“parking on any residential street between the hours of 10:00 pm. and 6:00 am after two inches of snow has fallen”** and this also be regulated by the *National Weather Services “winter storm warning”*.

*President Claeysen recommended that Attorney Jim Stevens submit a legal opinion as to whether or not the village needs to place in its ordinance the number of inches when declaring emergency winter parking regulations. Everyone agreed.*
